KF CSH were informed by Sustrans that the container for CSH was due. Unfortunately the suppliers have withdrawn, and Sustrans are now looking for new suppliers. KF suggested that, especially as bikeability are due to be putting their bikes into the container, CSH bikes are disposed of (most are in an unrideable condition). This was agreed as long as we are able to borrow Sustrans bikes on them odd occasion when necessary.

6 Events: planning considerations

- \cdot Go for a short ride in a safe place to show an adult that you can ride safely and confidently. Option 2
- · Find out about the safety equipment you need for cycling off-road.
- · Show that you're able to control your bike over different types of terrain.
- · Find out where, in your local area, is safe to cycle off-road.
- · Plan and carry out a five-mile cycle ride off-road.
